RENTAL AGREEMENT:

Please sign the Standard Equipment Rental Agreement & Acknowledgement and mail original to WIMSCO. An invoice for the first month rental of equipment and load/unload fees will be forwarded when we receive confirmation of a shipping date. You will be invoiced for a full month rental (one month minimum) in advance and payment is due prior to pick up of equipment. Each additional full month rental required will be billed and payable prior to the beginning of the next month. Lessee will be reimbursed any advance rental paid but not earned if rental period ends before the month ends. Please note that our terms are net due upon receipt of invoice. State and/or county sales taxes will be applied on our rental equipment when located and used in Wisconsin. If any local taxes are generated as a result of this rental agreement, they will be the responsibility of the lessee.

INSURANCE:

1. Please include a certificate of insurance verifying that the equipment is insured on an all risk equipment floater, or comparable form, for the valuation listed in the agreement, with WIMSCO, Inc. as an insured and as "loss payee" with maximum total deductible amount of \$2,500.00.
2. The certificate of insurance must also verify that Public Liability insurance including Contractual Liability to cover this agreement and Protection and Indemnity (P&I) has been obtained with limits of \$1,000,000.00 also naming WIMSCO, Inc. as additional insured.
3. Please include proof of insurance for Worker's Compensation, if not in a Monopolistic State, and that Subrogation has been waived against us on that policy. Where required by law, please include proof of insurance for Longshoremen, Harbor Workers Compensation and Outer Continental Shelf Compensation Insurance covering charterer's employees.
4. Please note our insurance company requires a 30-day prior written notice of cancellation of your policy.
